Safety and Security Information

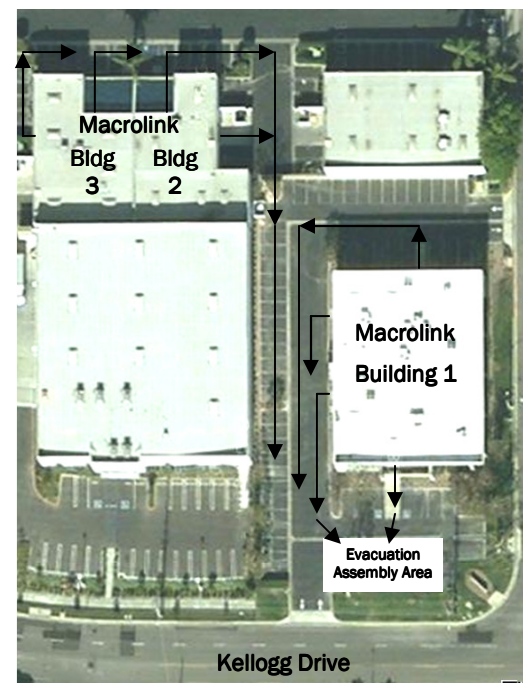
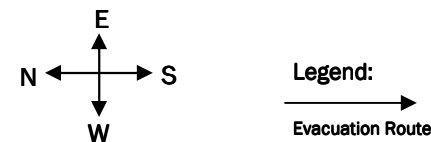

Safety Precautions

2. **Escort Required.** If you are provided an ESCORT REQUIRED visitor badge, please assist us by always staying with your host.
3. **Right to Search and Seizure.** Macrolink has a legitimate business interest to protect its property and employees. We reserve the right to search any package or personal property brought onto or taken from Company premises. Be aware you may be asked to participate in a security check of any packages or personal property you bring or take from the premises. Please cooperate with the security officer or receptionist as they perform their duties.
